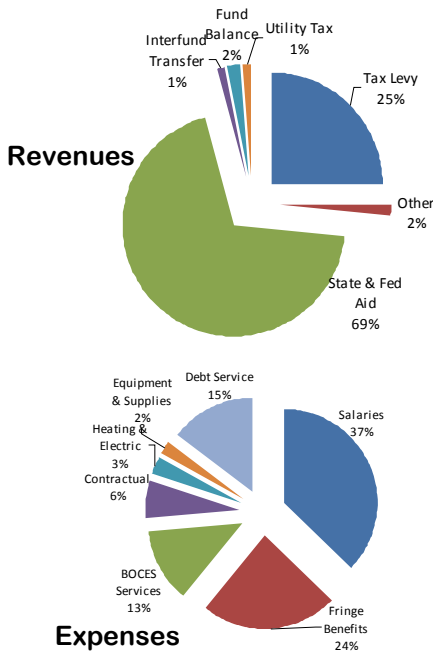

\*The school district's contingency budget for the 2011-12 school year is based on eliminating spending for certain supplies and equipment (including the purchase of school buses), and also eliminating all community use of school buildings that would incur district expense. A separate vote would then be required for the school bus purchases.

The annual budget vote for the fiscal year 2011-12 by the qualified voters of the Gloversville Enlarged School District in Fulton County, New York, will be held on Tuesday, May 17, 2011, between the hours of 11 a.m. and 8 p.m. prevailing time in six locations in said district, at which time the polls will be opened to vote by voting machine.

## VOTERS TO DECIDE ON:

### PROPOSITION No. 1

- "Shall the budget of the Gloversville Enlarged School District for school year 2011-12 as adopted at a meeting of the Board of Education in the amount of \$52,693,000 be approved and the Board of Education be authorized to raise the moneys for the purposes therein, provided by a tax levied on the taxable property of the district?"

Included in this budget is the purchase of seven vehicles five buses and two transport vans) in the amount of \$458,500. Gloversville is on a regular bus replacement schedule based on mileage, age of vehicles, repair history and condition. This cost will be offset by 90% state aid.

### PROPOSITION No. 2

- Which candidates should be elected to serve on the Board of Education?

Voters may choose up to three candidates for the Gloversville Board of Education. All of the seats are for three-year terms that expire on June 30, 2014. Candidates: Jean LaPorta, E.
